## Welcome/Call to Order:

## **Approval of the October 2024 Minutes:**

## **Treasurer's Report:**

Katy provided Dianne's report that the current balance was \$56,306.81 as of December 1. Income was provided by a \$5,000 donation from the Quinn Foundation and \$6.86 in interest accrued.

Expenses were \$595 for insurance and \$200 for Chamber of Commerce dues.

A discussion ensued as to the value of Chamber membership. Consensus was that they are helpful in promoting events.

Nancy R moved acceptance of the report, Ann seconded the motion and it was approved unanimously.

## **Superintendent's Report:**

Steve reported that the budget process has involved difficult decisions due to the age of some school buildings, and that the challenges have come

from trying to space out renovations.

The administration has begun a strategic planning process that will involve many of the "stockholders" in the school system, including SEF members.

The goal for this planning process is to define priorities over the next five years. He expects surveys to be sent out in mid-March to advance this goal.
